Earnings per share ("**EPS**") decreased by 26.5% to 40.0 cents per share, from 54.4 cents per share in the prior corresponding period.

Dividends per share ("**DPS**") for the full year decreased by 25.7% to 20.2 cents per share, from 27.2 cents per share in the prior corresponding period.

The directors resolved to declare a final gross dividend of 11.1 cents (2018: 16.2 cents) per share from income reserves in respect of the year ended 2019.
