Revenue decreased by 4.0% to R275 million, from R286 million in the prior corresponding period.

Headline earnings per share decreased by 13.9% to 25.6 cents per share, from 29.8 cents per share in the prior corresponding period.

Earnings per share decreased by 15.6% to 25.1 cents per share, from 29.8 cents per share in the prior corresponding period.

Dividends per share for the interim period decreased by 12.1% to 8.0 cents per share, from 9.1 cents per share in the prior corresponding period.

2. DIVIDEND DECLARATION

The directors resolved to declare an interim gross dividend of 8.0 cents (2019: 9.1 cents) per share from income reserves in respect of the six months ended 31 December 2019.
