### 1. SALIENT FEATURES

Revenue increased by 2.5% to R282 million, from R275 million in the prior corresponding period.

Headline earnings per share increased by 19.5% to 30.6 cents per share, from 25.6 cents per share in the prior corresponding period.

Earnings per share increased by 21.9% to 30.6 cents per share, from 25.1 cents per share in the prior corresponding period.

#### 2. DIVIDEND

In line with the Group's dividend policy, the directors have resolved to declare a final gross dividend of 10.0 cents per share (2020: 8.0 cents) per share in respect of the period ended 31 December 2020.

The dividend has been declared from income reserves. A South African dividend withholding tax of 20% will be applicable to all shareholders who are not exempt or entitled to a reduced rate in terms of the applicable double- tax agreement. The interim net ordinary dividend is 8.0 cents per share for ordinary shareholders. The issued share capital at the declaration date is 96 718 328 ordinary shares.
